- Looking toward a hybrid delivery for the Fall, will depend on many variables
- Reuter project is continuing with construction getting underway
- Finalizing an agreement about the PSW course being provided tuition free for domestic students and a credit to current currently enrolled
- President Tibbits is grateful to the CSI team for their work to present to City Council around Housing
- The original report was not flattering to students and going forward it will be important for the college and CSI to work together to push for solutions with the city

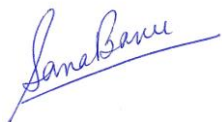
