- Transportation – much is centered around what their transportation future developments provide for students (not including UPass)
- Nelson asked about expansion of LRT closer to the college. This is not the case, however new routes are planned and a new bus hub is being built as feeders into the LRT. Also looking at bike paths, electric scooter rentals, etc.
- With regards to student housing, the Board could look at forming its own committee around this which would work into future boards
