### PROCEDURAL

We wish to acknowledge the lands where we live, learn, work & organize hold the ancestral connections and stories of Indigenous peoples. As we all know, colonization has orchestrated the displacement of Indigenous peoples from their ancestral lands which has hindered their ability to be in good relations with the land. Indigenous peoples are actively maintaining and strengthening their relationships with the land, which are grounded in respect, reciprocity, and resiliency.

The land our Brantford, Kitchener, Waterloo, and Cambridge campuses are located on represents the unceded territory of the Neutral, Haudenosaunee (Ho-deh-no-show-nee) and Anishinaabe (Ah-nish-nah-bay) peoples. This land was promised to the Haudenosaunee (Ho-deh-no-show-nee) people of Six Nations, which includes six miles on each side of the Grand River, known as the Haldimand

Tract. We also wish to acknowledge and recognize that the lands our Stratford, Ingersoll, Guelph & our future campus in Milton are located on represent the ancestral and treaty lands of the Anishinaabe (Ah-nish-nah-bay) peoples.

Our acknowledgement of the land is our declaration of our collective responsibility to this place and its peoples' histories, rights, and presence. We extend our respect, friendship & solidarity to all Indigenous peoples for their past, present & future contributions to this land and our community, and in their past, present and future struggles.

CSSI Budget Notes (2024-2025)

- This budget was prepared prior to the cap announcement and projected a 30% decrease in enrolment.
- There will be a budget revision in the future
- Most food services project slightly reduced revenue with exception of catering which projects the same
- Reduced revenue from chiro and physio based on current use
- New line item, CSI Support Services. CSI subsidizes CSSI salaries and this line shows the transfer of funds. Will cover a bit of the projected loss
- Shubham – how are we missing government subsidies? Nelson – sometimes we received work-study funding but are receiving about a quart of what we received in the past
- Shubham – high expenses and small revenue from Food Truck. Sheena – the F & B team has put in a lot of effort to ensure a good plan for spring. Are approved for the food truck collective group which allows us into the community for books. The collective has a condition where we can't undercut prices like we do for our students. There is also a larger marketing plan for this year
- Shubham – when will budget revision occur? Nelson – probably in the summer as previous years
- Sheena – seeing an overall decrease of 30% from previous year. A 40% decrease in first year international enrolment will require a further decrease so fall and winter are budgeted at 40% reduction with the cap coming into effect in September
- Sheena – important to note we don't have confirmation around enrolment. Because winter enrolment was high we will see about \$1 million surplus from this fiscal.

Asking this board to inject it into next year's fiscal budget to allow for time to collect all data to make proper decisions.

- Nelson – this is a fair request to ensure decisions are not rushed. The \$1 million is recommended to go into operations for the next fiscal to main while we wait for confirmation on numbers. Shubham – agree with focus on sustaining operations, if we return to “normal” it would be good to try to get the reserves back to level.
- Shubham – can the SLC renovation be paused? Sheena – it is too far along; however funds were saved for this. We are moving forward with the areas the college is moving forward with. Any unused funds must go back to the board for approval.
